## 2. Update paper – finance/risk

The Risk Register and update on the budget paper were discussed by the Commission. Amendments were agreed to scores for some items on the risk register as further mitigating measures had been put in place.

# 3. Population Health Strategy – Richard Foggo, Director of Population Health, Scottish Government and Malcolm Summers, Head of Strategic Reform

Richard Foggo, Director of Population Health, Scottish Government gave a presentation on plans for the development of a future strategy for health and wellbeing. This was followed by a discussion with the Commission about how to ensure that poverty and inequality is at the heart of future strategy and how to engage all the community in a conversation about what is needed.

## 4. Council Tax – draft letter to ask SG for update on discussion on Council Tax

The Commission discussed the approach it would like to take around the on-going cross-party talks on council tax reform in Scotland. The Commission agreed to send a letter to all political parties in Scotland to ask them for an update, from their perspective, on how the talks were going and for details of their party's stance on council tax and the extent to which impacts on poverty, inequality and revenue raising are being considered.

### 5. Development of the Strategic Plan: Discussion on Impact

The Commission discussed the development of the Commission's strategic plan for 2020-22, which the Commission plans to publish in June 2020. The discussion particularly focused on how the Commission would define its impact.
