## 1. Welcome and apologies

Bill Scott welcomed everyone to the meeting.

### 2. Commission business as usual

# **Annual Report**

The Commission's Framework Document sets out that the Commission is required to produce an annual report of its activities, together with its budget expenditure, within three months of the end of each financial year. Katherine Hudson gave an update on the Commission's draft Annual Report which was circulated for comment and for Commissioners approval. The report has been approved and sent for approval to the Scottish Government Sponsorship Team. It will be published on the Commission's website by the end of June.

# **Update on Child Poverty Delivery Plan progress report**

Katherine Hudson gave an update on the Scottish Government's Child Poverty Delivery plan progress report which was due to be published in June but may be pushed back to August once Parliament is back in session. The Commission is still waiting to receive progress updates from the Scottish Government in order to scrutinise progress and advise the Scottish Government on the progress report. The Commission's advice will be published at the same time as the Scottish Government publishes its progress report.

## 3. Covid-19 short-term response work

# Update on the food insecurity survey

Katherine Myant gave an update on the Food Insecurity Survey which has been carried out carried out by Professor John McKendrick, Scottish Poverty Inequality Research Unit (SPIRU) on behalf of the Commission. SPIRU's report of the survey findings will be published on the Commission's website on 8 June, along with a briefing providing the Commission's recommendations. 3x1PR will issue a press release on the same day as the publication.

## 4. Covid-19 input into recovery and renewal

## **Potential request for input from Scottish Government**

Bill Scott updated the Commissioners on the meeting he had with the team within the Scottish Government Performance and Strategic Outcomes Directorate who are working the SG's COVID-19 strategic recovery response (called the 'Renew Programme'). The meeting was to discuss their work and talk about how the Commission's work might feed into and complement the Scottish Government's work and how the Commission could act as a sounding board in future renewal work.

## **Round Table with Cabinet Secretaries**

Bill Scott gave an update on the round table meeting on social renewal with the Cabinet Secretary for Communities and Local Government and the Cabinet Secretary for Social Security and Older People. The Cabinet Secretaries will be looking to establish a more formal Social Renewal Advisory Board and have asked if Bill Scott would like to be part of the Board. Lived experience will need to be part of the board and the Commission will ask how this can be brought to the table.

# **Update on response to Advisory Group on Economic Recovery**

Katherine Hudson provided an update on the request received by the Commission from the Advisory Group on Economic Recovery to seek the views of the Commission on how the Scottish Government sets the course and direction of Scotland's economic recovery in response to the impact of Covid-19. The Commission submitted a response to the call for evidence. Benny Higgins, Chair of the advisory group has requested to meet with Bill Scott and the secretariat is in the process of setting up a meeting.

# **Update on potential research with the Social Mobility Commission**

Katherine Hudson updated Commissioners on potential research work to be carried out jointly by the UK Social Mobility Commission and the Poverty and Inequality Commission. A Memorandum of Understanding is being drafted on how the two Commissions will work. A joint advisory group to discuss the research work will be set up between both Commissions with both secretariats attending.

Katherine Myant gave an overview of the proposed research which will look at how the current pandemic will affect young people. The research will focus on specific groups of young people and how they will be affected by the Covid-19 crisis. Commissioners suggested groups of young people the research work could focus on young asylum seekers, disabled young people and the impact of homelessness on young people during the crisis. It was agreed that both Commissions should link in with the Children's Commissioner. The MOU and a draft specification of the work will be circulated to Commissioners once developed.

## **Future expert seminars/discussions**

The Commissioners discussed the recent expert seminar/discussion where they had invited a number of experts to talk about the implications of COVID-19 on poverty and inequality, in order to help the Commission start to develop its work to look at the long term impacts and the changes to policy and practice which will be needed.

Commissioners agreed the sessions were useful and hold to other seminars/discussions at future meetings. Commissioners suggested groups that could be invited to future meetings, including grassroot groups who could give an insight into the issues that they face with a focus on lived experience. The Commissioners were asked to send suggestions to Katherine Hudson on particular groups to invite. It was also suggested that it would be useful to invite the Cabinet Secretary for Fair Work, Economy and Culture to have a discussion about the wellbeing economy.

Lindsay Graham noted that it had been useful to visit local community groups to get a broader insight into the work they are carrying out and that the Commission should try to do more of this.
