1. Welcome and apologies

Bill Scott welcomed everyone to the meeting. Apologies were given for Yvonne Blake, Douglas White and Katie Schmuecker. Bill Scott thanked Joanne Smith, and Susan Galloway NSPCC Scotland and Maureen McAteer, Barnardos for joining the meeting.

2. NSPCC to present their research findings

NSPCC Scotland and Barnardos Scotland gave a presentation to the Commission on their new research, *Challenges from the Frontline*. The research is a follow-up to 2013 research and revisits the same services to look at the impact of welfare reforms and austerity on families and family support.

3. Intersectionality research draft report

Katherine Hudson provided an update on the draft discussion piece on intersectionality from IPPR Scotland. Commissioners provided comments and agreed to ask IPPR to remove the recommendations for the Scottish Government. The Commission will consider which recommendations it wants to make to Scottish Government and also to reflect on any recommendations made by the First Minister's Advisory Council on Women and Girls and will discuss at the next Commission meeting in January. Commissioners agreed to publish the report once final changes are made in January.

4. Biodiversity duty report

Katherine Hudson provided an overview of the Commission's Biodiversity report 2019-2020. Under the Nature Conservation (Scotland) Act 2004, all public bodies in Scotland are under a statutory duty to further the conservation of biodiversity when carrying out their responsibilities. The Commission reviewed and agreed the Biodiversity report. The report will be published by the end of the year on the Commission website.

5. Budget/risk register/work plan

The Commissioners discussed the budget, risk register and work plan. Commissioners agreed updates to the risk register.

6. Social Renewal Advisory Board report update

Bill Scott provided a verbal update to Commissioners on the Social Renewal Advisory Board. The Social Renewal Board final report to the Scottish Government will be will be published in January. The Commission will publish its contribution in full after the SRAB report is published.
