### 4. Tax Working Group

Bill Scott introduced the paper on the Tax Working Group. As part of its 2022-23 work programme the Commission agreed to establish a working group to look in more detail at how taxation can better address poverty and inequality in Scotland The paper sets out a proposal for the tax working group to be taken forward from October 2022 to June 2023.

Commissioners were asked if they would like to volunteer to join the group, Bill, Shona and Alex agreed and invites will also be extended to Commissioners who had given apologies for this meeting. Experts by Experience Panel members will also be invited to the working group. Once the group is up and running members will be asked for suggestions for external membership which will be agreed with the working group chair. The secretariat will consider how the group and the Commission may wish to respond to fiscal and tax issues arising from recent UK Government fiscal statements and the Scottish Government Emergency Budget Review, to be discussed at the next Commission meeting in October.

# 5. Research Proposals

Bill Scott introduced a research paper which sets out four different research topics that are candidates for making use of the Commission's research budget this year was shared. The Commissioners discussed the proposals and provided suggestions to the secretariat.

# 6. Local Child Poverty Action Reports
