1. Welcome and apologies

Bill Scott welcomed everyone to the meeting.

2. Pathfinders discussion

Christina Stokes, Head of Policy Engagement, Covid Recovery, Scottish Government and Gillian Cross, Policy Lead, Place Based Social Justice, Scottish Government joined the meeting. The Commission had agreed that it would invite policy teams with responsibility for commitments in the Child Poverty Delivery Plan to meet with the Commission to discuss progress with those commitments. SG officials presented to the Commission an update on the Dundee and Glasgow Pathfinders, then there was an opportunity for the Commission and Panel members to have a further discussion and to ask questions.

Scottish Government officials talked through the learning from Dundee and Glasgow pathfinders to date. The Place Based Social Justice Division hosted a National Learning Event on 5th December for local authority, public health and third sector leaders and a second learning event is planned for Spring 2023 and an invite was extended to the Commission for this.

As part of the Scottish Government Pathfinders evaluation programme, SG officials are working with an external contractor to conduct an evaluability study, and Commissioners indicated an interest in seeing the outcome of this work.

3. Pathfinders follow-up discussion

The Commissioners and Panel members had a follow-up discussion on the Dundee and Glasgow Pathfinders and reflected on what they had heard at the presentation. The secretariat will follow up with Scottish Government with further questions from the Commissioners and Panel Members.

4. Tax Working Group update

Shona Stephen provided an update on progress of the Tax Working Group. Other Commissioner members of the group are Bill Scott, Alex Cobham and two Experts by Experience Panel members, external members are Professor Mike Danson from Heriot-Watt University, and Joanne Walker of the Low Incomes Tax Reform Group. The group have had two meetings with all members present and others planned in February, March and April where the working group will invite external experts to come along to talk through various issues on tax. The group will offer recommendations on taxation for the endorsement of the wider Commission during summer 2023.

The Commissions website will provide information on the Tax Working Group, and the group's minutes will be published on the website. The Commission will be kept updated on the working group at regular intervals.

5. Intersectionality

Katherine Hudson provided an update on next steps in developing the Commission's intersectional analysis strategy. Talat Yaqoob Consulting will review some of the Commission's work so far and work with Commissioners and Experts by Experience Panel members to deliver training sessions on Intersectionality. The initial sessions are expected to be held either February or March.
