# 1. Welcome and apologies

Stephen Sinclair, Chair of the Commission, welcomed everyone to the meeting. Apologies were given for Paul Fletcher.

## 2. Scrutiny report and discussion on recommendations

Stephen Sinclair introduced the paper on the draft Child Poverty Scrutiny report and discussion on recommendations. Following the scrutiny meetings with Scottish Government officials, the discussion at the last Commission meeting, and the joint meeting between Commissioners and Panel members, the secretariat has prepared a first draft of the scrutiny report for the Commission to consider. Stephen Sinclair noted that he may have a perceived conflict of interest in relation to the Fairer Futures Partnerships scrutiny work due to his involvement through SPIRU in the Communities of Practice and therefore would not participate in any discussion relating to this aspect of the scrutiny report. It was agreed that Suzanne Fitzpatrick would sign off this aspect of the report.

Commissioners discussed the recommendations, the overall tone of the report and provided comments and feedback to the secretariat. Commissioners noted that data and improving data might be an area for a smaller group of the Commission to look at in future. Taliah Drayak and Ross McQueenie volunteered to participate in any future work on data. This will be considered further after the scrutiny report is complete in the context of other work priorities the Commission could pursue after its statutory child poverty duties for this year are complete.

The secretariat noted that, based on the discussion a set of recommendations would be drafted and circulated to Commissioners on 21 April. A second draft of the report would then be circulated on 28 April. The secretariat asked Commissioners to provide:

- Any further comments on the draft scrutiny report to the secretariat by end of the day 22 April
- Comments on draft recommendations by 9am 28 April
- Comments on second draft of report by end of the day 5 May

The Commission will agree by correspondence that the Chair can approve the final draft of the report on behalf of the Commission, with the final report then being sent to Scottish Government by 12 May.
